3. Model's Representations and Warranties The Model represents and warrants that:
  - They are of legal age (18 years or older) and have the full legal capacity to enter into this Agreement, or, if a minor, have obtained the consent of a parent or legal guardian as indicated by their signature below.
  - They have the right to grant the permissions outlined in this Agreement without violating any third-party rights or obligations.
  - The Work does not require the consent of any other person or entity to use the Model's likeness as described herein.
4. Release and Waiver The Model hereby releases, discharges, and agrees to hold harmless the Agency, their agents, assigns, and licensees from any and all claims, demands, or causes of action that the Model may have, including but not limited to claims arising from the use of the Work, defamation, invasion of privacy, right of publicity, or any other claim related to the Model's likeness or participation in the Work.
5. Governing Law This Agreement shall be governed by and construed in accordance with the laws of the United States of America in which the Headquarters of the Agency is based, without regard to its conflict of law principles.
6. Entire Agreement This Agreement constitutes the entire understanding between the parties and supersedes any prior agreements, whether written or oral, relating to the subject matter herein. Any amendments to this Agreement must be made in writing and signed by both parties.
7. Severability If any provision of this Agreement is found to be invalid or unenforceable, the remaining provisions shall continue in full force and effect.
